Highlight Video: \$300 - a fun, condensed version of your entire wedding coverage, running from 10 to 45 minutes, depending on your preference and the length of our coverage. This is a great addition to your master tape, and a great way to present your wedding to friends and family who may not have time for the full version. We actually re-edit the master tape with a mixture of video montage and real time footage, to create a fun, moving piece for a great small price.

Mileage outside Boulder/Denver metro FOR EACH VIDEOGRAPHER: •Aspen: \$200 + hotel; •Beaver Creek: \$100; •Vail, Keystone, Breckenridge, Colorado Springs: \$90; •Fort Collins, Estes Park, Castle Rock: \$50 •Lyons, Longmont, Chief Hosa, Evergreen, Genosee, South Denver: \$30. The videographer will require a hotel room for evening weddings 100 miles or more from Boulder, and possibly for winter weddings in the mountains (depending on weather).

Copies of highlight tapes, video copies & raw footage: \$50/each. Copies of DVD videos: \$150/ 1st copy, \$75/subsequent copies. Please note: we cannot and do not guarantee that your DVD player will be compatible with our DVD's

Bonus / incentives:

- 5% of the value of coverage toward products for weddings Monday - Thursday;
- \$50 toward products or services for each successful referral to Walkabout;
- \$50 in products given on request directly to your coordinator, reception planner or other wedding professional.

Terms and Conditions

1. Exclusive Videographer. Walkabout Ltd. shall be the exclusive videographers retained by the Client for the purpose of videographing the wedding. Family and friends of the Client shall be permitted to video the wedding as long as they shall not interfere with Walkabout Ltd.'s duties and do not get in the way or cause delays.

2. Deposit and Payment. The Client shall make a \$500 deposit to retain Walkabout Ltd. to perform the services specified herein. The deposit is nonrefundable. *The Client shall pay the balance due at least 1 week prior to the wedding date. Failure to do so will void Walkabout's obligations.* Videos take 4-8 weeks from your wedding date.

3. Cancellation. If the Client shall cancel this Agreement at any time the client shall be charged the amount of the deposit. If the Client shall cancel this Agreement within thirty (30) calendar days before the wedding date, the client shall be charged the entire balance due.

4. It is the clients responsibility to inform Walkabout of any restrictions at a reception site or ceremony site that may affect Walkabout's ability to adequately perform their duties. The client understands that such restrictions may adversely affect the quality of their video, and that Walkabout is not responsible for the consequences of such restrictions. Further, the Client understands that, while Walkabout will make every effort to capture good sound and a good picture, we will not be responsible for circumstances preventing this, such as difficult weather conditions, people walking or standing in front of a camera, poor acoustics or difficult lighting. The client also understands that Walkabout will not be responsible for missing any part of the wedding day if Walkabout has not been given adequate warning of that particular occurrence.

5. Walkabout will provide the client with a completed video of their wedding. The Client must inform Walkabout within 14 days of receiving their video of any technical or quality problems associated with the video. Walkabout will then, at their discretion and at no charge, attempt to rectify those problems (see 4. above). Any editing changes to the content requested by the client (e.g. changing music, scenes in or out, etc.) will be charged to the client at \$75/hr.

6. Copyright and Reproductions. Walkabout Ltd. shall own the copyright for all footage created and shall have the exclusive right to make reproductions: any unauthorized copying of videos constitutes an infringement of this copyright. Walkabout Ltd. shall only make copies for the Client or for the Videographer’s portfolio, samples, or self-promotions. If Walkabout Ltd. desires to make other uses, Walkabout Ltd. shall do so with the permission of the Client. Walkabout Ltd. may choose to sell the copyright and footage to the client in regard to their wedding, and will make a reasonable effort to contact the client before disposing of any footage.

7. Client’s Usage. The Client is obtaining videos for personal use only, and shall not sell said videos or authorize any reproductions thereof by parties other than Walkabout Ltd.

8. Failure to Perform. If Walkabout Ltd. cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond its control, or due to Videographer’s illness, then Walkabout Ltd. shall return the money paid by the Client, less the nonrefundable deposit, in respect to that specific failure, and shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that videographic materials are damaged in editing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Walkabout Ltd. In the event that Walkabout Ltd. fails to perform for any other reason, Walkabout Ltd. shall not be liable for any amount in excess of the retail value of the Client’s order.

7. Walkabout Ltd.’s Standard Price List. The charges in this Agreement are based on Walkabout Ltd.’s Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

8. Client’s Originals. If the Client is providing original prints, or footage owned by the Client to Walkabout Ltd. for duplication, filming, or any other purpose, in the event of loss or damage Walkabout Ltd. shall not be liable for an amount in excess of \$5 per image.

9. Miscellany. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. This Agreement shall be governed by the laws of the State of Colorado.

The parties have read both the front and back of this Agreement, agree to all its terms, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as Client below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.
